Sound Equipment

1. Any production provided by purchaser must be approved in advance by Jeremiah Cook – NO EXCEPTIONS.
2. Doug Moreland shall be accommodated with, at no cost to him, a sound check on performance stage, scheduled with the approval of artist, and to conclude before doors open to the public. The sound check will be as fully equipped and professionally staffed, with sound engineers, as the scheduled performance(s).

Payment

1. All deposits must accompany the signed contract no later than 14 business days after receiving the contract from KB Talent. All deposits must be made out to **Doug Moreland, NO EXCEPTIONS**. Send deposit to KB Talent ATTN: Shelby Vanek. Address is 1514 Ed Bluestein Blvd Suite 108 Austin TX. 78721.
2. All payments to be made at the conclusion of the show must be in the form of cash or cashiers check made payable to **Doug Moreland** unless otherwise agreed upon in advance. No checks or cashier's checks made out to anyone other than the artist will be accepted. IF a check is written for payment, the buyer/venue must be able to cash out the check in full, on site, at time of settlement.
3. If the wages are a percentage and/or expenses are factored into the wage agreed

purchaser shall provide:

- A. Printer's manifest and box office statement signed by purchaser.
- B. Verification of all expenses related to the show via invoices, receipts, ad schedules, logs, etc.
- C. A final accounting of all gate receipts and show costs. All shall be presented in an organized manner upon final settlement with Jeremiah Cook.

Performance

1. Unless otherwise agreed upon, Doug Moreland will perform one set of 120 minutes.
2. Any opening act/band provided by purchaser must be approved in advance. Please call KB Talent for approval. Pre -approved openers - Cody Shaw, Matt Skinner, Corb Lund, & 1100 Springs. Opening bands shall be paid for by venue/buyer.
3. The stage plot, dimensions, must be given to Jeremiah Cook prior to show for review and approval.
4. If the performance is out doors an elevated, covered, safe, stage must be provided unless otherwise agreed upon in advance.
5. No portion of the performance may be broadcast, recorded, filmed, taped, or embodied in any form for any purpose of reproducing such performance for profit. Replay of the performance for future advertising, promotion, etc must be approved by artist.
6. The correct billing of the artist is **The Doug Moreland Show** (if space doesn't permit, please use Doug Moreland; NOT, The Doug Moreland Band). Artist's name must appear at the club or on the marquee and all advertisements correctly. A copy of each printed advertisement (news paper, ad, poster, etc) and cassette copy or cd of all radio ads associated with the performance are to be presented to Jeremiah Cook during settlement.

Accommodations

1. Artist requires 3 double occupancy (non-smoking) hotel rooms (or a \$300 room buyout) reserved in advance under the name of Doug Moreland unless otherwise agreed upon in advance.
 - A. Hotel information including address, phone number, and reservation number/s must be given to Jeremiah Cook at least 7 days prior to show date.
 - B. If the hotel room buyout option is chosen the buyout must be paid, in cash, to Jeremiah Cook at time of load in.

Hospitality

1. One dressing room with a working lock on the door or a security staff member to watch the room during Doug's performance is required, unless other arrangements have been made in advance.
2. 1 case of bottled water provided for band.
3. 1 case of cold Budweiser Beer & 1 case of cold Bud Light provided for band.
4. 5 clean and dry hand towels provided on stage for band.
5. If this is an event where alcohol is not permitted, please provide 1 case of bottled water, (1) 12 pack of Coke and (6) 32oz bottles of Gatorade, various flavors.
6. One ice chest, on stage, filled with ice, with the beverages inside it.

Food

Artist requires 1 meal per band/crew member (6) or a \$12.00 buyout in cash per person at load-in time. If meals are provided by venue please have a designated private or semi-private

area for the band to eat. The buyout must be given to Jeremiah Cook at time of load in, NO EXCEPTIONS.

Parking

Artist requires that purchaser provide adequate parking space for tour vehicle and trailer (at least 45' in total length) in a location that is of close proximity to and with direct access to the backstage area.

Complimentary tickets

Artist requires complimentary tickets for sponsors, fan club members, and any other guests to be determined by artist. A guest list will be issued to the venue prior to showtime and must be approved by Jeremiah Cook and/or Shelby Vanek.

Merchandise

A well lit, high trafficked, clean area must be set aside for Doug Moreland's merchandise set up.

Security

Purchaser shall provide adequate security for Artist and backstage area including tour vehicle/trailer.

Please provide us with as much information as possible to advance the show and to help any last minute scenarios be worked out.
